- 1. Opening of meeting by President: 114 members present, 5 guest presenters.
 - a)President Wib Paul welcomed the gathered members to the meeting and called the meeting to order at 10:00 hrs.
 - b) The meeting was opened with the playing of O Canada.
 - c)A power-point presentation was displayed in memory of members who have passed away since our last meeting.
- 2. Minutes of the AGM held on October 6, 2016 were posted on the ROFFA website.
 - a) Motion to accept the minutes of the April meeting.
 - 1. Moved by Dave MacCormac, Seconded by John McCarthy. Carried unanimously.

3. President's Report:

- a) Wib Paul welcomed the members and speakers to the meeting and gave some opening remarks.
 - 1. The President informed the members about the new website and thanked Bob Larochelle and his daughter Julie for their hard efforts in changing over the website.

- 5. Ottawa Carleton Pension Association Report: Ralph Smith
 - a)Ralph reported that there has been very little action on the transition to OMERS. OMERS has asked the City of Ottawa to pay several million dollars plus the proceeds of the COSF plan in order for them to take the plan over. So far the City is unwilling to pay as they feel the plan is solvent.
- 6. Ottawa Fire Fighters Community Foundation: Brian Conway
 - Brain informed the members of the new upgrades that are being planned for the memorial site and described the concepts to the group.
 - Brian also reminded members of the Memorial March and reception that follows.
- 7. Unfinished Business:
 - Pierre Potvin gave his final update regarding sources for less expensive travel insurance.
 - Pierre advised that it is not feasible for ROFFA to become a sponsor group due to the administrative issues that it would create. He informed the members that it might be of value for them to join the United Seniors Citizens of Ontario through a single or family membership that will allow them access to a wider range of discounted insurance brokers.

- c)Dan provided an overview of what affect the new probate legislation will have on all estates in Ontario and how incredibly complicated it has become.
- d)Reverend John Brydges spoke about his role as the Fire Service Chaplain and provided some history about how he joined the clergy and how he ended up as our Chaplain.
